### **OUR COMMITMENT TO ISSF**

As Founding Members of the International Seafood Sustainability Foundation, Thai Union Europe strongly support all initiatives undertaken by ISSF. In compliance with ISSF Conservation Measure 2.4 and 2.5 Thai Union Europe have committed to publicly report the amount of fish that we source from:

#### **Fishery Source:**

- MSC Certified
- Fisheries that have entered full assessment for MSC certification
- Fisheries in the MSC Fisheries in transition to MSC (ITM) program
- Comprehensive FIPs that have been publicly listed and have achieved progress within at least the past 24 months; or are in their initial year of listing
- Comprehensive FIPs that have been publicly listed but have not achieved progress in the prior 24 months

THAI UNION EUROPE have made it a priority to reduce its purchase from the None of the Above category by directly engaging with our suppliers and boat owners, encouraging them to partner with us by joining this commitment to supply chain transparency. THAI UNION EUROPE implemented an internal program to review and monitor our progress and find innovative ways to increase our sourcing from vessels and companies meeting the above criteria.

The Thai Union Tuna Commitment is to source 100% of our tuna by the 31<sup>st</sup> December, 2025 from fisheries which are MSC certified, in MSC full assessment, in a comprehensive FIP or in a In Transition MSC fishery.

As part of the ISSF 2023 – 2027 Strategic Plan, THAI UNION EUROPE commits to sourcing only from fisheries that can meet and maintain the MSC standard by the end of 2027. THAI UNION EUROPE commits to incrementally increasing MSC fisheries tuna sourcing with the below roadmap:
